

End-User License Agreement (EULA) of "Jumping Frog|Robot"

This End-User License Agreement ("EULA") is a legal agreement between you and WE ARK SAS.

This EULA agreement governs your acquisition and use of our software "Jumping Frog|Robot" (hereafter called "The Software") directly from WE ARK SAS or indirectly through a WE ARK SAS authorized reseller or distributor (a "Reseller").

Please read this EULA agreement carefully before completing the installation process and using The Software.

License types

Trial : Not for commercial use. For testing purpose only, this licence is valid for 30 calendar days from the license delivery date and can only be used on one computer. It is limited to the construction and deconstruction of models containing up to only 30 bars, 10 surfaces (claddings and panels) and 60 nodes.

Student : Not for commercial use. This license is granted to students, upon presentation of a valid student document. The license is valid for 1 year from the license delivery date and can only be used on one computer.

Education : Not for commercial use. This license is granted to schools or faculties, upon presentation of a valid document. This license is valid for 1 year from the license delivery date for up to 30 computers.

Pro : Full featured license, valid for 1 year from the license delivery date and can be used for commercial use.

Zoo license : Education and Pro licenses can be shared between a specified number of computers using McNeel's Zoo. The license granted can only be used on the computer hosting the Zoo server.

Hardware ID : License are link to one computer using a unique hardware ID. This hardware ID can be subject to changes when replacing computer's hardware parts. A new license, matching the new hardware ID can be requested a maximum of 3 times a year. WE ARK SAS reserves the right to refuse to issue a new license if a misuse or fraud is suspected.

License Grant

WE ARK SAS grants to you a personal, time-limited, non-transferable and non-exclusive right to use the copy of the Software provided with this EULA.

You are not permitted to:
